Dog License – Unaltered (Not Spayed or Neutered), 5-1—4 B \$24.00

*Spaying/Neutering Certificate (if not already on file with Town Clerk). Cannot be licensed as spayed or neutered without proof of such surgery was performed.*

Dog License Tag Replacement, 5-1—4 B, \$2.00

Private Kennel Permit (Three to Five Dogs), 5-1—14 E \$75.00

Commercial Breeding Permit (No more than Five Dogs), 5-1—14 E \$75.00

Sportsman Permit (No more than Five Dogs), 5-1—14 E \$60.00
